Invitation for Bids for the Construction of 15 Bed Hospital Building Aiselukharka, Khotang

1. The Government of Nepal [GoN] *has allocated funds* towards the cost of Construction of 15 Bed Hospital Building, Aiselukharka, Khotang and intends to apply part of the funds to cover eligible payments under the Contract for Construction of 15 Bed Hospital Building Aiselukharka, Khotang (IFB NO: ARM-KHO-07/2078-79/NCB). Bidding is open to all eligible as per Section V of bidding document.
2. **Aiselukharka Rural Municipality, Khotang, Province- 01** invites electronic bids from eligible bidders for the Construction of 15 Bed Hospital Building Aiselukharka, Khotang under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **190 million(Excluding VAT)**
 - Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, in at least 1 (one) Hospital building Construction Works with a value of at least NRs 140000000.00 that have been successfully or a substantially completed within the last five (5) years, each and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 2.1 of the Bidding Document.

5. Bidders May download the bidding documents for e-submission from PPMO website www.bolpatra.gov.np/egg. Bidders, submitting their bid electronically, should deposit the cost of NRs. 10,000/- of bidding document in the projects Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposited voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egg on or before **12:00hrs** on **2078/11/29**. Bids received after this deadline will be rejected.
3. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs on 2078/11/29** at the office of **Aiselukharka Rural Municipality**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs.45, 00,000/-** which shall be valid for 30 days beyond the validity period of the bid.
