6. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 Hrs of (2078/10/15) at the office of Aiselukharka Rural Municipality, Aiselukharka Khotang. Bids must be valid for a period as mentioned in table below after the bid opening and must be accompanied by bid security issued by an authorized bank (A class commercial bank) or scanned copy of bid security in pdf format in case of e-bid amounting to a minimum as mentioned table below, which shall be valid for minimum 30 days beyond the period of bid.
7. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. The person, Firm or company black listed as per public procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another new firm or company.
9. Matters not covered by this notice shall be in accordance with public procurement Act-2063 with amendment and public procurement regulations, 2064 with amendment and other prevailing regulations. Aiselukharka Rural Municipality, Office of the Rural Municipal Executive reserves the right to accept or reject wholly partially or all the bid without assigning any reasons what so ever.
