1. The Government of Nepal [GoN] *has allocated funds* towards the cost of Construction of RCC motorable bridge at Liding Khola, 25.00 *1 nos. Span (total length 26.2 m), Khotang and intends to apply part of the funds to cover eligible payments under the Contract for Construction of RCC motorable bridge at Liding Khola, 25.00 *1 nos. Span (total length 26.2 m), Khotang (IFB NO: ARM-KHO-07/2077-78/NCB). Bidding is open to all eligible as per Section V of bidding document.
2. **Aiselukharka Rural Municipality, Khotang, Province- 01** invites electronic bids from eligible bidders for the **Construction of RCC motorable bridge at Liding Khola, 25.00 *1 nos. Span (total length 26.2 m), Khotang** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **60 million**
 - Minimum Work experience of similar size and nature: **at least experience of two number of RCC bridges having span not less than 20m and cost not less than 35 million**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

A complete set of Bidding Documents may be purchased from the office of **Aiselukharka Rural Municipality, Khotang, Province- 01** by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of **Nrs.5000** till 2077/10/08 *during office hours*.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp or before **12:00hrs** on **2077/10/08**. Bids received after this deadline will be rejected.
8. The bidswill be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs on 2077/10/08** at the office of **Aiselukharka Rural Municipality**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs.1,020,000/-** which shall be valid for 30 days beyond the validity period of the bid.
